## Infamous Abortinist Begins Practice in Abortions in Maryland

Leroy Carhart – the infamous Nebraska abortionist who challenged the federal partial-birth abortion ban – has begun doing abortions in Maryland today.

Carhart has joined Germantown Reproductive Health Services, an existing abortion facility specializing in first trimester abortions. Carhart is known for performing abortions up to 22 weeks gestation, and perhaps beyond.

Carhart has [stated that he left Nebraska after the state passed a fetal pain bill](#). The new law bans elective abortions after 20 weeks on the grounds that the unborn child feels excruciating pain. He said his new location would be in a jurisdiction with "favorable" abortion laws.

Maryland, with [one of the most permissive abortion law in the country](#), has provided a haven for Carhart and his ilk. Maryland's only meaningful protective regulation is that abortion must be performed by a licensed physician (not necessarily one with background in reproductive health or gynecology). Notably, [NARAL considers this a "restriction"](#) that prevents "qualified health care professionals" from providing abortions.

Nearly all of Maryland's neighbors have protective medical standards regulating abortion.
